# **RULES & REGULATIONS EAACI Congress Scholarships**

The provided text outlines the rules and regulations for EAACI Congress Scholarships, including the benefits, rules, proof of attendance requirements, payment process, and data privacy considerations.

## **SCHOLARSHIP BENEFITS**

- A scholarship includes €500 for travel and accommodation expenses to attend EAACI Hybrid Congress 2024. Travel and accommodation arrangements are the scholarship recipient's responsibility
- It also includes a standard congress registration for EAACI Hybrid Congress 2024.

## **RULES**

- Scholarships are meant for the physical registration to the EAACI Hybrid Congress 2024 only.
- If a scholarship recipient cannot attend due to illness, force majeure, or other unavoidable circumstances, the scholarship may be forfeited, and the recipient must justify their absence.
- Scholarships recipients must be EAACI Junior Members at the time of application.
- Scholarships recipients are responsible for all paperwork, including visas and study leave.
- A scholarships recipient is eligible for one source of funding only. If additional funds are available, the EAACI Selection Committee should be informed for reallocation.
- Priority for scholarships allocation is given to applicants who have not received schlarships in 2023.

#### PROOF OF ATTENDANCE

- Physical presence at the EAACI Hybrid Congress 2024 in Valencia, Spain, is mandatory.
- The scholarship recipient must attend the entire congress from Friday, May 31, to Monday, June 3, 2024.
- Attendance is recorded onsite by signing in and out at the EAACI Campus desk with a national identity card/passport on the first and last days.

# SCHOLARSHIP PAYMENT

- Personal bank details must be provided on a secured platform after the congress.
- All contact details should be updated on MyEAACI for smooth operation.
- Payment will be made after the EAACI Hybrid Congress 2024, once physical attendance is confirmed.

# PERSONAL DATA PRIVACY
